Standard 1311 of the IIA's *International Standards for the Professional Practice of Internal Auditing* calls for "Ongoing monitoring of the performance of the internal audit activity" Whether carried out in-house or outsourced to a third party, it is critical to understand and recognize the key drivers and deliverables of successful internal audits. With internal audit being sometimes viewed as a mere support function or a department that constrains the company from meeting its objectives, the department should be able to show that it is performing effectively and adding value to the company.

With this program, auditors at all levels will be able to appreciate the contributions of the internal audit department towards meeting enterprise-wide objectives. By understanding, discussing, developing and analyzing metrics-based dashboard, attendees can identify what is important to their success and strive to achieve success for themselves and the department.

Through lecture, facilitated discussions, and hands-on exercises, attendees will acquire the necessary skills in developing metrics and defining customized dashboards. Attendees who have existing dashboards will have the opportunity to validate, compare and enhance their dashboards. Attendees will be able to take away a sample dashboard template comprising a comprehensive listing of performance indicators.
